Jag har som underlag för min bedömning tagit del av relevanta styrdokument samt protokoll. Jag har följt styrelsens arbete genom protokoll.

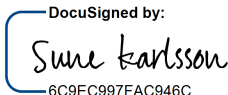

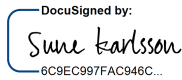
